From the Brainstorming to the Book

When Nobel laureate Paul Crutzen argued first during a workshop of the International Geophysical and Biological Research Programme (IGBP) in late February 2000 in Cuernavaca (Mexico): "We are now in the Anthropocene!" he provoked a controversial debate first among the Geologists, later among the natural sciences and with some delay also in the social sciences, humanities and even in different religions.

My proposal for this workshop was that as an outcome of an intensive one day brainstorming we should reflect on the origins of this concept and its meaning as a new concept for framing and structuring scientific debate in our respective scientific disciplines and research programmes and for multi-, interdisciplinary and transformative research in the natural and social sciences (conceptual analysis, methodological debate).

By narrowing the focus on 'Politik' in its triple meaning of politics, policy and polity the brainstorming addressed new insights and areas of knowledge by employing this concept in political history and theory, in policy analysis and in international relations focusing on peace, security, development and the environment.

Therefor my proposal is that all those interested to contribute to a volume should prepare background or concept papers of up to 3-5 pages or 1000-1500 words as kind of thesis papers or extended scientific abstracts. These papers may reflect on or address the following questions:

- a) Why is my discipline using this concept and interested to develop it further (scientific interest guiding its cognition process) in its scientific work (motivation)?
- b) *How do we understand* the concept of the 'Anthropocene' from a disciplinary and research back-ground (conceptual analysis and working definition)?
- c) What is my prospective research question I would like to address in my planned chapter and what is the scientific context (research programme, theoretical context)?
- d) What is my (hypo)thesis I would like to explore and develop in my planned chapter?
- e) Will this concept help me to conceptually frame my theoretical and empirical work addressing key anthropogenic challenges for nature (Earth System) posed by us as human beings and humankind?
- f) How may this concept be employed and applied in analysing 'Politik' as processes, fields, institutions and norms?
- g) What is the potential of the concept of the Anthropocene as a political concept inspiring and guiding political actions in a new era of earth history where humankind has for the first time intervened into nature and may undermine and threaten the very survival of our species due to the impacts of anthropogenic global environmental and climate change?
- h) What is the potential added value of the Anthropocene concept as a framework of analysis in the social sciences and as a tool or guideline for actions in the political arenas or in practice?

We taped the brainstorming session and will make these tapes electronically available in a password protected website of AFES-PRESS to allow all participants to listen later to the discussions when you are writing the first draft of your chapter. We may have one or two rounds of reviews: a) among ourselves only (first round) and b) including external reviewers or discussants you may suggest as most competent experts in your respective field. The goal of this review process is to help us collectively and individually to develop our own ideas further and to sharpen our argument to provoke a debate in the social sciences as well, what Paul Crutzen has achieved with his hypothesis: "We are now in the Anthropocene" in February 2000 in Mexico.

Process, Structure, Deadline and Schedule

The goal is to publish in autumn of 2018 a peer reviewed book on this theme as volume 30 in the Book Series: The Anthropocene: Politik – Economics – Society – Science (APESS).

Suggested Book Schedule (to be discussed)

- 31 October 2017: deadline for submission of first drafts of chapters (of about 3.000-7.000 words in English) for the peer review process
- November 2017: Commenting period among authors on the other texts of co-authors
- 1 December 20 January 2018: External discussion of peer review process
- 20 January 15 March 2018: Submission of the final revised book chapters
- 16 March 30 April 2018: Copyediting of the whole book
- 15 April 30 May 2018: Language editing of the whole book
- 1 June -30 September 2018: Book production
- November-December 2018: Publication as a book and Ebook (Publication date 2019).

We may consider to launch this book during the International Studies Association (ISA) Conference in 26-29 March 2019 in Toronto, Canada and to have a roundtable a year later during the ISA Conference 26-28 March 2020 in Honolulu (Hawaii). These two events were approved by the AFES-PRESS Board on 2 June 2017 during our board meeting in Mosbach.
